### The President's Corner

Fallacies.

It seems that events almost always overtake my thoughts on what comments to make in this publication. This time the events seem to reinforce the need for a bit of clear thinking.

Fallacies of thought and argument may seem necessary, today more than ever before. We have, as a nation, become seriously divided and, guess what, over politics. In this context, some words about the most prevalent fallacies of thought suddenly seem appropriate. If you ever took debate in high school or university, you may recognize these fallacies. And, I shouldn't hesitate to add: this is far from a complete treatise on these fallacies; it is only a brief treatment of two or three of them that seem particularly appropriate.

The *argumentum ad hominem* argument seems to be particularly common today. It falls into the class of irrelevant appeals. This argument completely avoids – in fact dismisses – any argument on the merits of the premise (to use debate terms) and, instead, makes the “man [or woman] the argument.” The personality of someone is attacked and the argument is shifted from the merits of the argument that is actually being made. It is as though all of the arguments, both pro and con, are rendered no worth of discussion or dialogue, rather the maker of the argument becomes the topic. The shape of this fallacy is often recognized in the form that I'm not going to meet your argument and offer alternative or show why your position should be rejected, rather, you are unworthy and therefore your

position should be rejected. If we agree that the person making the argument is a bad person, then the merits of their position, whatever it may be, are also bad and should be rejected. The definition is “an irrelevant, personal, derogatory attack.” Rather than confront the actual issue, we attack the messenger.

Somewhat similar is the *guilt by association* fallacy. This transfers the argument away from the merits of the discussion (indeed, they are evaluated as irrelevant) to the proponent’s associations or memberships or even those who travel along side. If we stop for a moment and think about it, we can all see instances of this fallacy. And it infects both politics and other areas. The most prevalent instance that is cited is that employed by then-Senator Joe McCarthy. Turned around, the argument appears that because some politician failed to reject a statement by another, that they have adopted the statement and are to be tarred with the same brush.

Another that seems currently popular is the *tu quoque* fallacy. This is the Latin phrase for “you too” or, sometimes, “your another.” In other words, the party asserts that they should not be criticized because the accuser is also guilty. That may well be, but it is irrelevant to the main point regarding the behavior. For example, you should not criticize on (whatever point) because you also fail on (the same point). Sometimes this is called blame-shifting. The issue that should be at the forefront is the main point of the argument or the criticism of the behavior; what the proponent does or does not do doesn’t justify or support the main point of the argument.

There are many more logical fallacies that could be discussed and this is only a brief jump into the thinking (or lack of it) that seems to infect our discussions and, most visibly, the airwaves. I admire those folks that are able to recognize these on the fly as it were, and that takes some clear thought and often some courage to point them out.
